FIS PASSPORT application

- 1. Database contains all Events (race series) and LOC Information
- 2. Accredited persons (with exception of LOC volunteer groups) to **register personally** in the system (Additional Data Privacy Policy in place)
- 3. Select Events participating ("apply") and
 - a. add Covid-19 Test results (will also be saved in Test history)
 - b. fill in Whereabouts for defined period (14 days)
- 5. Pre-event **health** questionnaire will be sent 6 days prior to first race (+daily health check)
- 6. Status reviewed for participant by LOC as defined by its protocol/rules

FIS PASSPORT - DATA LINK FOR LOC'S

this solution module is free of charge for LOC's – we implemented this now in the FIS Passport Application

We have foreseen the following GDPR compliant procedure, based on the data needed for the LOC:

The LOC gets a specific login to see and eventually download the actual status of the participants, who registered in the FIS Passport Application for this specific event. If this event is postponed or shifted, the login remains the same.

The LOC gets the data only for people who registered for event:

- In specific, this is the information if the participant submitted per-event questionnaire, submitted the Whereabouts and completed the health questionnaire.
- Additionally, information about registered and uploaded event related Covid-19 tests, concerning the above-mentioned people are visible.
- Information can be shown per participant or shown as full list and the full list can be downloaded as Excel sheet for further processing or import to other systems.

If the LOC is using the LOC PASSPORT System, the event relevant data from FIS PASSPORT will be imported automatically to the LOC PASSPORT SYSTEM.

NO double registration would be necessary, as the registration is done anyhow at the FIS PASSPORT System for this specific event.

This offer supports and eases the onboarding and registration, but specifically also the LOC need of detailed documentation about the health measurements taken.

The NSA's will have an overview page with a dedicated login (TAN code) for each NSA in order to check the status of their athletes/members within the FIS PASSPORT SYSTEM.

Functionalities:

- Status per NSA to be downloaded as CSV/Excel file
- Link to landing page for each NSA with login:
 - Filter on NSA, Country, discipline, gender
 - Status (completed / pending) with the following status criteria:
 - Test-upload done
 - Pre-Race Questionnaire done
 - Whereabout done until the day before query (d -1)
